**Thank you** for agreeing to be a Performer for the Copa Centenario Opening Ceremony.

The commitment required of you will be to attend rehearsals as scheduled (approximately 7 sessions prior to Show Day) and to have fun! There will be a number of benefits to being involved including a prize drawn every rehearsal for those in attendance and other exciting surprises to be announced during rehearsals.

To be eligible to take part in the Ceremony you must:

- Agree to the Terms and Conditions in this form.
- Provide the information as requested.
- Sign the form in the spaces provided. If you are under the age of 18 your parent or guardian will need to sign as well.

## TERMS AND CONDITIONS

### I agree

1. **(Performer)** that a "Performer" is a person who volunteers to participate according to the script of the Ceremonies;
2. **(Obligations)** to be a Performer means undertake to participate as a performer for COPA CENTENARIO, (including their directors, officers, employees, contractors, subcontractors, volunteers, or agents), ("**PRODUCER**"): to take part in the holding of a performance in the course of organizing, staging, rehearsing, and holding the Opening Ceremony of the Tournament, regardless of whether or not such act was staged and/or performed in the framework of the final version of the above Ceremony.
3. **(Duties)** where advised by PRODUCER, to attend all rehearsals and performances (if applicable to my role), to attend all training sessions and to participate as scheduled by PRODUCER. I also agree to wear the official uniforms or costumes as advised or provided by the PRODUCER;
4. **(Policies)** that policies and procedures for staff of the PRODUCER might be relevant to me. I will be notified if such policy is relevant to me and I will adhere to it;
5. **(Intellectual property)** to notify the PRODUCER of any ideas or materials which I may create in relation to my provision of my participation and, by signing this form, I transfer to the PRODUCER all rights and interests in these creations (such as copyright) and waive all moral rights in such creations;
6. **(Personal property)** to safeguard my personal property located at any premises or venue at which I attend whilst participating. I understand and agree that the PRODUCER is not responsible for any lost, stolen or damaged personal property:
7. **(Health and Safety)** that I declare that my health conditions are sufficient for attending rehearsals. I will not do anything to compromise my health or safety or the health or safety of others and I understand that there are risks associated with providing voluntary services. I agree to release and hold harmless the PRODUCER for any injury sustained while participating in the ceremony and understand that I must have my own health insurance coverage in case of accident or injury. I also agree not to be under the influence of alcohol or illegal drugs while participating as a Performer.
8. **(Medical)** that the PRODUCER might require me to provide medical certifications or information about my health status prior to rehearsals for the period of my involvement.
9. **(Promotions)** not to be involved in any promotions, not to talk to the media and not to engage in public speaking about my activities as a Performer or about the Ceremony, including all forms of social media, unless I have received the prior written consent of the PRODUCER to do so. I also agree not to engage in any activities which may (in the PRODUCER's opinion), adversely affect the PRODUCER's interests. I also agree not to assist any other person or organisation in doing any of the activities prohibited in this paragraph;
10. **(Security checks)** that COPA may conduct identity verification, background and other security checks in relation to me. I also agree that the PRODUCER may inspect my personal property when I enter or leave any venue related to my participation as Performer. I also agree that, to the extent permitted by Law, PRODUCER may request and receive information from other Countries, police services or other agencies, to identify amongst other things, prior adult or juvenile convictions;
11. **(Claims)** that, if, as a result of my act(s) or omission(s) whilst participating as a volunteer, I suffer any damage or loss to my property or I suffer any injury, I will not bring any claim against the PRODUCER (including their directors, officers, employees, contractors, volunteers, or agents), and I also agree not to bring any claim against police services or other agencies in relation to their release of information referred to in paragraph 10.

12. **(Recordings)** that the PRODUCER (or its representatives) may record on film, photograph and broadcast my performance(s) and any appearance(s) live and can record, photograph and film my likeness, image, sounds, and voice during my participation ("Recordings"), and that the PRODUCER is entitled to edit, adapt, add to or subtract from the Recordings and to broadcast, reproduce, publish, and sell the whole or any part of the Recordings (or any version of the Recordings and authorise others to do the same on any media or in any format now known or yet to be devised for any purpose throughout the universe. I agree that the PRODUCER may assign and/or license all such rights to others (or any version of the Recordings) and agree to waive all my moral rights in the Recordings (or in any version of the Recordings);
13. **(Personal Photography)** that I am not allowed to take photographs, film, or otherwise record the Ceremony or any rehearsal. This also applies to participation whilst performing. If I breach this provision, I agree that all intellectual property rights in such photographs, film or other recordings will be owned by the PRODUCER and I agree to deliver these up to the PRODUCER.
14. **(Termination)** that PRODUCER may terminate my participation as a Performer at any time upon notice to me;
15. **(Laws)** that this Agreement is governed by the Laws of the State of California. I also agree to sign any other documents that the PRODUCER may require to have affect to the terms on this agreement; and
16. **(Confidentiality)** to keep confidential all information and materials concerning the PRODUCER, the activities with which I am involved as a Participant and the Ceremony, which I know or should reasonably know is confidential.
17. **(Personal Data)** By signing the Agreement, I agree to the processing of my personal data for the purpose of rehearsal.
